Program Policies & Requirements

1. Classroom Lessons:

- Attendance in class is mandatory.
- No more than two (2) absences allowed; more results in removal without refund.
- Makeup work must be arranged with the instructor.
- Arriving late counts as an absence
- Cancellation of class will coincide with the cancellation of school (Snow days and early release).

2. Driving Lessons:

- Consists of ten (10) hours of driving and six (6) hours of observation. This is in addition to classroom lessons.
- Lessons and observations are scheduled in advance with the instructor.
- Missing a driving lesson without notice: **\$85 fee** (payable by **cash, money order, or bank check** - no personal checks).
Please Note: 24-hour cancellations are allowed without penalty.
- Arriving late for a scheduled driving session may result in a charge for that session.

3. Course Completion Requirements:

- Must complete 10 hours driving and 6 hours observation.
- Must document 40 hours of driving with parent or other adult in addition to the 10 hours of driving school lessons.
- Must pass class requirements with 80% or higher.
- Must complete all assignments
- Must have a signed Green Slip Release Form from a parent/guardian
- Must return all course materials in good condition
- Note: Students failing must retake (and repay for) the program.

4. Behavior and Conduct:

- No food or drink in classrooms or vehicles.
- Students must make time for required driving; repeated refusal may result in removal without a refund (parents will be contacted first).
- Students who are disruptive, disrespectful, or combative toward any teacher or fellow student will be dismissed from the program without a refund.
- Any cell phone use during class or in a vehicle is considered disruptive unless the instructor has granted prior permission.

5. Payments and Fees:

- \$75 fee for any returned checks.
- The complete cost of the program must be paid in full by the end of the second class to maintain a seat in the program.
- Students will not be allowed driving hours if a missed driving fee is not paid
- A \$75.00 fee will be required to reissue a Green Slip DSMV 210 if lost, damaged or incorrect information is supplied to the company.

6. Students are expected to complete all required driving sessions as scheduled. Repeated refusal to drive due to other commitments (work, sports, personal, etc.) may result in removal from the program without a refund if proper accommodations are not made. A parent or guardian will be contacted to discuss the issue before any removal takes place.

7. Late pickups will incur a fee, as instructors have scheduled commitments after each lesson.

- 1–15 minutes late – \$25
- 16–30 minutes – \$50
- 31–45 minutes – \$75
- 46–60 minutes – \$100, and so on.

8. Green Slip Certificates

- A Green Slip Certificate is awarded to each student upon completion of the program.
- It is proof of successful course completion
- It does not mean or imply in any way that the student is capable of operating a motor vehicle without continued proper adult supervision.
- I understand Granite State Driving School **strongly encourages** continued Parental Supervision as a student operates a motor vehicle.
- It is the Parent/Guardian's responsibility to decide when the student is prepared to drive independently.
- The Parent/Guardian agrees to assume all risks and **full responsibility** for any injuries, damages, or losses that may occur as a result of their child operating of a motor vehicle.

Registration & Payment Procedures

Option One:

1. Please complete this Student Enrollment Contract in full.. Save it to your computer and email it to granitestatedriving@gmail.com. Please include the **COURSE NUMBER** in the subject line of your email.
2. Make a payment using our secure payment link. You may pay the full tuition of **\$800 for classes beginning before July 1, 2026, or \$825 for classes beginning after July 1, 2026**; alternatively, you may submit a **non-refundable \$250 deposit**. Payment may be made by **credit card or an ACH bank transfer**. Please be advised that a 3% processing fee will be added to all credit card transactions.

Option Two:

1. Please complete this Student Enrollment Contract in full. Save it to your computer and print it out.
2. Mail all the pages, along with a deposit of \$250 or the full tuition of **\$800 for classes beginning before July 1, 2026, or \$825 for classes beginning after July 1, 2026**.

Please Note: The State of New Hampshire limits driver education classes to a maximum of **30 students**. Enrollment at Granite State Driving School is accepted on a **first-come, first-served basis**.

Please Note: By submitting this form electronically, you confirm that your electronic signature is valid and binding, just as if you had signed the document in person. You also agree that all information provided is true and complete.

Once a student has been given a reserved place in the class that you have selected, the deposit becomes non-refundable*. Students however, may move to a different class up to 14 days prior to the start of class without penalty provided seats are available. Applicants requesting to be placed in a different class will be held accountable for the deposit fee 14 days prior to the start of class. Any student that fails to show up/ attend the class will forfeit the deposit for the seat. \$250.00

Acceptance of this application and permission form will be based on a first come, first serve basis and also the availability of driving times.

***Explanation of Non-refundable deposit:** Any money paid with an application is considered refundable. If the student does not get placed in the class you chose, you have the option of signing up for another class or a getting a full refund. Once a student is given a place in the class you requested, the deposit then becomes **non-refundable**.
